SUBJECT: Assignment of Codes "Y2" for Section 1107 of FY04 Supplemental (Train and Equip Authority) for the Afghanistan National Army and "Y3" for Section 1107 of FY04 Supplemental (Train and Equip Authority) for the New Iraqi Army - Security Assistance Management Manual (SAMM) E-Change 16 (DSCA Policy 04-27)

Effective immediately, SAMM Table C4.T2., Country and International Organization Codes and FMS Eligibility, is updated to add the codes "Y2" and "Y3" to track funds provided under Section 1107 of FY04 Supplemental (Train and Equip Authority) for the Afghanistan National

Army (Y2) and for the New Iraqi Army (Y3). The Defense Security Cooperation Agency must authorize use of this code for Letters of Offer and Acceptance documents.
